

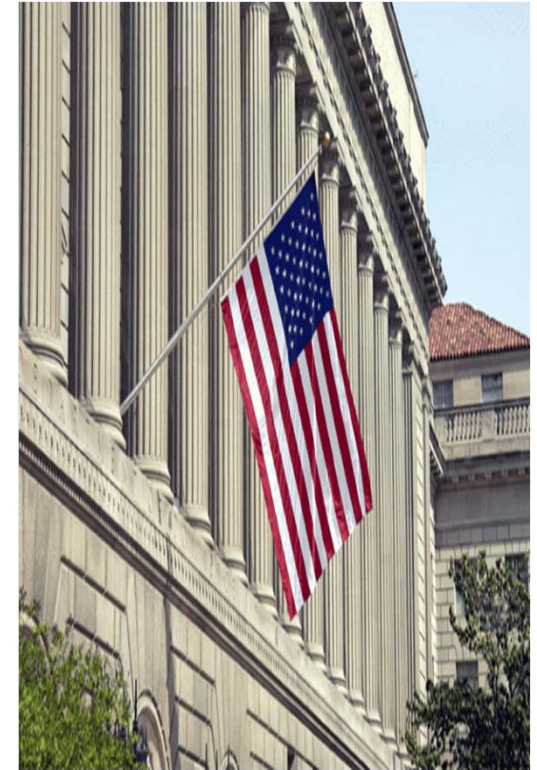
Who We Are

What is the Timeline?

The BAS project timeline encompasses three implementation phases.

In the first phase, **ALL** DOC bureaus will be participating in the up-front system decisions including data standardization, architecture (solution) design, system configuration and set up, EDW design and build, and business process reengineering.

 - Go-live - October 1, 2023

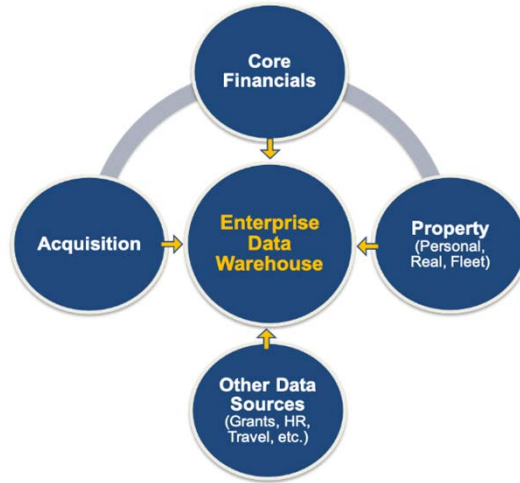

What is BAS?

The Business Applications Solution (BAS) project is a U.S. Department of Commerce modernization initiative to deploy an integrated suite of financial and business management applications in support of our mission.

The Secretary of Commerce identified BAS as one of the top Departmental priorities. The objectives include implementing and integrating a suite of commercial off-the-shelf (COTS) business systems, enterprise data warehouse (EDW) and business intelligence (BI) reporting solution, and system interfaces in a hosted environment. The BAS Project will continue the ongoing emphasis on achieving organizational excellence and outstanding customer service for the Department.



What's the Scope?

The BAS Project includes dedicated, DOC business applications for:

- ❖ Core Financial Management (including loans, financial statements (FASB and FASAB) and interfaces)
- ❖ Acquisitions Management
- ❖ Property Management (personal, real, and fleet)
- ❖ Enterprise Data Warehouse and BI reporting (to include data from BAS, Grants, Travel, and HR/Payroll)
- ❖ Data Archiving Solution
- ❖ All related administrative system interfaces

BAS Implementation includes all bureaus except USPTO.
